## **RESOLUTION NO. 2024-34**

A RESOLUTION OF THE CITY OF FELLMERE, FLORIDA LOCAL PLANNING AGENCY/PLANNING AND ZONING COMMISSION RECOMMENDING THAT THE CITY OF FELLMERE CITY COUNCIL ADOPT RESOLUTION 2024-35 WHICH ADOPTS AN UPDATED AND MODIFIED REDEVELOPMENT COMMUNITY PLAN FOR MAKING IMPROVEMENTS TO ELIMINATE BLIGHTED CONDITIONS WITHIN THE COMMUNITY REDEVELOPMENT AREA AND CALLING FOR THE COMMUNITY REDEVELOPMENT **AGENCY TERM** AND COMMUNITY REDEVELOPMENT PLAN TO BE EXTENDED TO FORTY (40) YEARS SUNSETTING ON OCTOBER 1, 2046.

**WHEREAS,** The Local Planning Agency/Planning and Zoning Commission for the City of Fellsmere, Florida (the "LPA"), received the Modified Community Redevelopment Plan (the "Modified Plan") from the Community Redevelopment Agency (the "CRA"); and

WHEREAS, the LPA has reviewed the Modified Plan for consistency, compatibility, and compliance with the Comprehensive Plan for the City of Fellsmere, Florida (the "City") for the development of the City as a whole; and

WHEREAS, on \_\_\_\_\_\_2024 the LPA held an advertised public hearing and determined that the Modified Plan is in conformance with the City's Comprehensive Plan for the development of the City as a whole; and

**WHEREAS**, the LPA recommends that the City Council proceed with consideration and adoption of the proposed Modified Plan for the Community Redevelopment Area, with an extension of the CRA term and Community Redevelopment Plan, as modified to Forty (40) years sunsetting on October 1, 2046.

**NOW, THEREFORE, BE IT RESOLVED** by the Local Planning Agency/Planning and Zoning Commission for the City of Fellsmere, Florida, as follows:

**SECTION 1.** The Local Planning Agency/Planning and Zoning Commission for the City of Fellsmere, Florida, in accordance with Section 163.360 (4) Florida Statutes 2023, held a Public Hearing on \_\_\_\_\_\_\_ 2024, regarding the proposed Modified Plan and determined that the Modified Plan is consistent and compatible with, and seeks to implement portions of the City's Comprehensive Plan for the City as a whole.

**SECTION 2**. The Local Planning Agency/Planning and Zoning Commission for the City of Fellsmere, Florida recommends that the City Council proceed with consideration of the proposed Modified Plan within the current boundaries of the Community Redevelopment Area, with an extension of the term of the CRA and Community Redevelopment Plan to Forty (40) years sunsetting on October 1, 2046.

**SECTION 3.** The Local Planning Agency/Planning and Zoning Commission for the City of Fellsmere, Florida, recommends to the City Council that they adopt Resolution No. 2024-35 modifying the Community Development Plan for the existing Community Development Area and extending the term of the Redevelopment Agency and the Community Redevelopment Plan to Forty (40) years sunsetting on October 1, 2046.

**SECTION 4.** This Resolution shall become effective immediately upon its adoption.
